This guidelines and terms and conditions for submitting an EOI are provided below.

Eligibility Criteria:

- 1. Coaching institutions must possess a legally recognized status and operate within the applicable legal framework.
- 2. Proven track record of more than 3 years in providing high-quality education and coaching services.
- 3. Demonstrated expertise in coaching for the course they submit Eol for.

Submission Process:

- 1. Interested institutions will complete the provided EOI template available at CCPC website.
- 2. Ensure all required information is accurately filled in the template.
- Submit the completed EOI along with all supporting documents before deadline and mail to <u>contactccpc@uok.edu.in</u> as one PDF file. Don't forget to mention course and academy name in subject of the mail.

Evaluation Criteria:

- 1. Track record in coaching for competitive exams, high success rates in any exam, of the students of any academy will be an important parameter for selection.
- 2. Commitment to student success, as evidenced by past achievements, reviews and testimonials.
- 3. Years of experience of coaching for the examination for which academy submits Eol.
- 4. Teaching experience of tutors in years.
- 5. Quality of study material.
- 6. Quality and originality of question papers

Terms and Conditions:

- 1. Collaborative efforts will be subject to a formal agreement, specifying the scope of coaching services and legal obligations of both parties.
- 2. The selected coaching institution must adhere to the set of standards and guidelines by CCPC.

- 3. CCPC reserves the right to terminate contract if the coaching institution fails to meet specified legal and performance standards.
- 4. The extension or continuation will be based on performance and students' feedback.
- 5. Complete material for any courses, question papers for weekly/monthly/model or mock tests be provided by academy along with resource person. The evaluation of all the examination is to be done by academy.

Legal Compliance:

- 1. All participating coaching institutions must comply with local, state, and national legal requirements.
- 2. Submission of legal documentation validating the coaching institution's status and compliance with education-related laws is mandatory.
